## Rationale

The company ROMAX TRADE DOO, Novi Sad, 2, Dositejeva Street, submitted to the Ministry of Domestic and Foreign Trade, on 31 March 2023, the request for registration with the Registry of the Entities Authorised to Perform the Affairs of Export and Import of Armament and Military Equipment, Brokerage Services and Technical Assistance, kept with this Ministry.

The Ministry of Domestic and Foreign Trade considered the submitted request and the documents prescribed for the registration with the Registry, and, upon their evaluation, it found that the request was justified, so it decided as in the wording hereof, based on the application of the provisions of art. 7(1, 5, 6) of the Law on Export and Import of Armament and Military Equipment.

**Instruction on Legal Remedy:** A complaint against this decision to the Government of the Republic of Serbia is allowed within 15 days as of the day of receiving the decision.
